Abstract

Postgraduate studies in England (Master's Degree)

General characteristics

The average duration of the courses is 1-2 years with a fee range of 3.000-20.000 pounds per year for Public Universities. 1.Southampton university

International Maritime Management programme

The courses aim to help people who are hoping to advance their career in the maritime industry. Solent University's MBA (MANAGEMENT BUSINESS ADMINISTRATION) International Maritime Management programme helps you to develop industry awareness, focusing on management practices, day-to-day operations and the international markets that drive this exciting industry.

The course combines traditional MBA content with focused elements unique to the world of shipping and maritime business. Throughout the studies, a greater understanding of the diverse and multi-faceted maritime industry is developed, along with the complex interactions that occur on a global level between the numerous organisations, such as shipping companies, port authorities, businesses and governments.

In keeping with an MBA programme, you'll study key management-related areas such as human resource management, data analysis and finance and business risk, building upon your existing knowledge. These core management modules are combined with specialist maritime studies including international maritime law, maritime operations and transport and economics of international trade and shipping.

People who attend the course will enhance their research and analytical skills on a specialist research unit. The unit prepares students for a major research project, where original research into a specific area of the maritime industry is carried out. This project is a good opportunity to develop specialist knowledge, with many graduates using their research as a springboard for future careers. - A UK first degree at 2:1 or overseas equivalent or a good recognised professional qualification
- A candidate without a good first degree or equivalent may be accepted onto the programme with a minimum of 4 years' management experience, at the discretion of the programme leader. We welcome applicants from a diverse range of backgrounds. Applicants who are not in possession of the minimum entry requirements but are able to demonstrate aptitude, enthusiasm and motivation will be considered on an individual basis and may be admitted subject to satisfactory interview and/or portfolio. English language requirements

Applicants who do not have English as their first language will be required to demonstrate an approved level of proficiency in the use of the English language. The agreed minimum requirements for this course are:

- IELTS minimum 6.5 overall with minimum of 6.0 in writing and a minimum of 5.5 in reading, listening and speaking
- TOEFL IBT 92 with minimum of 22 in writing and a minimum of 19 in reading, listening and speaking or equivalent.

Qualifications are checked before enrolment, and international students must bring their original certificates or certified copies when coming to study at the University.

The University also offers a Pre-Sessional English Language Course for international students who wish to improve their level of English before starting a degree course.

WHAT IS BEING STUDIED

Human Resource Management and Leadership

A successful leader needs to develop and improve a range of definable skills that are pivotal to successful management practice and to effective leadership. These include critical thinking and decision-making skills, HR management techniques, team working and interpersonal skills and others associated with developing personal effectiveness and credibility.

Research and Project Proposal

This unit develops the students' research and academic study skills and introduces them to the research process. It details the theoretical underpinning philosophies of research along with the methodological options for both data gathering and data analysis. It focuses on the identification and preparation for a discipline-specific research project.

Maritime Operations and Transport

Maritime transport is driven by supply and demand of both natural resources and manufactured goods which in turn dictate the trade routes utilised and the markets within which they operate. In order to facilitate this trade there are a wide range of vessel types with specialist operational and regulatory requirements. This unit is aimed at delivering a highly intensive programme of study that will review specific requirements for these different vessels and the factors that influence the trade routes and drive the markets. Sustainability and protection of the marine environment will also be addressed

Information and Data Analytics

Understanding the strategic importance of information technology to support the successful management of an organisation and its day to day decision making is vital. The aim is for students to be statistically aware by concentrating on the conceptual and practical application of statistics rather than the theoretical and numerical underpinnings.

Management of Strategy and Organisational Change

Examine advanced strategic concepts within an international corporate context focusing on maritime organisations. Develop the ability to recognise the increasing competitiveness and volatility in an ever changing global business environment whilst seeking to critically assess these challenges to make well-reasoned decisions contributing to the success of organisations.

International Marketing

The emphasis will be on business-to-business marketing strategies and on how these can create competitive advantage for a shipping business.

Economics of International Trade and Shipping

Students will appreciate and comprehend the fundamental principles of international trade and establish the transferable skills and the problem-solving techniques that they will need if they are to give appropriate advice or recommendations on practical commercial problems.

Finance and Business Risk

This unit requires students to critically reflect on the relevance and integration of finance theories, in terms of how they can be applied to contemporary real world issues. Examples and cases from international financial markets and corporations will be used to develop students' knowledge and critical understanding of complex financial relationships within the wider maritime business environment.

International Maritime Law

This unit provides the opportunity for the student to critically evaluate the development, aims and applications of International Maritime Law. Special attention is given to problem-solving through the use of a negotiating exercise. The unit investigates the allocation of rights and duties concerning the exploitation of natural resources in the marine environment, and international and European regulation of shipping and the marine environment.

Independent Maritime Business Research Project

The unit provides the opportunity to develop and carry out research applied to an area relevant to the programme of study and in an area of personal interest to the student and which is also relevant to a student's future career.

ii)MSc Superyacht Design

ABOUT THE COURSE

It focuses on naval architecture and on the designing of the next generation of superyachts. Solent's unique superyacht design master's programme – the only one of its kind the UK – blends naval architecture and structural design with management skills to help provide essential career-boosting skills.

The course concentrates on sailing and motor yachts over 24 metres in length, and is intended not just for naval architects and students of yacht design, but also now provides suitably qualified marine engineers and certified deck officers with experience of operating superyachts the opportunity to develop their qualifications, where traditionally the career path for yacht officers has not enabled them to progress onto pure naval architecture degrees. The blend of naval architecture (for which sea-going officers will have underpinning knowledge), management and structural design will enable students from these backgrounds to develop their knowledge and understanding, and introduce new and relevant material and subjects for master's level study. Course delivery is based on 'hands-on' active learning, with an emphasis on developing students' analytical and problem-solving skills, as well as gaining the appropriate knowledge to tackle an individual design or analysis project. Students benefit from strong industry links built through the University's highly-regarded yacht engineering undergraduate degrees, as well as experienced teaching staff with industrial and research experience. iv)MSc International Shipping and Logistics

This course runs from September to September. Between September and June you will study 120 credits of taught modules from a range of both obligatory core modules and a range of options. The taught phase concludes in June and, subject to successful completion, you then progress to the dissertation phase. Through the writing of the dissertation, you will acquire and develop research skills relevant to your choice of subject. The dissertation is submitted in early September.

The first semester contains two compulsory modules on maritime policy-making and shipping management, and two optional modules that the students selects from a wide range of courses which will supplement the compulsory components.

The second semester consists of one compulsory module that provides research methods which act as groundwork for the dissertation and three more courses of the student's choice.

The core modules are:

- **Research Skills and Methods:** This module provides postgraduate students with a comprehensive understanding of contemporary approaches to the design, conduct, and evaluation of research for students of the Logistics and Operations Management Section.
- **Maritime Economics:** Provides students with a thorough understanding of the scope of economics in the field of international shipping and the opportunity to practice and enhance their analytical skills in maritime economics and aims to advance the intellectual development of students through the application of the tools of economic analysis to approach both microeconomics and macroeconomics issues related to a complex industry affected by both endogenous and exogenous factors.

- **Maritime Policy:** This module will provide students with a systematic understanding of the maritime sector. In doing so, students will:
 1. Gain a firm foundation of knowledge in the working of the maritime industry and the policy environment within which it operates
 2. Evaluate the role of international, regional and national policy
 3. Develop advanced knowledge of safety, security and environmental protection issues
 4. Critically assess the role of the major stakeholders in relation to maritime safety issues and evaluate the importance of accident analysis.

Optional Modules:

“The University is committed to providing a wide range of module options where possible, but please be aware that whilst every effort is made to offer choice this may be limited in certain circumstances. This is due to the fact that some modules have limited numbers of places available, which are allocated on a first-come, first-served basis, while others have minimum student numbers required before they will run, to ensure that an appropriate quality of education can be delivered; some modules require students to have already taken particular subjects, and others are core or required on the programme you are taking. Modules may also be limited due to timetable clashes, and although the University works to minimise disruption to choice, we advise you to seek advice from the relevant School on the module choices available.”

The program provides a wide range of professional skills and can lead to a wide variety of job opportunities. There are career opportunities in ship operating/management companies, protection and indemnity clubs (P&I Clubs), Risk Management Companies, Port Authorities, Port Authorities and the International Maritime Organization- IMO. Each year, the university in conjunction with affiliated industrial partners are offering a limited number of projects for the most suitable students in the dissertation phase.

The tuition fees are £8,350(about 9,632€) for students from the United Kingdom and the European Union and £20,950 (about 24,167€) for students outside the EU. These fees may increase annually in line with inflation.

The entry requirements suggest Candidates will normally be graduates from a recognized university in related fields such as transport, engineering, business/management disciplines, geography, law, social sciences, maths and humanities. In some cases, non-graduates with significant work experience may also be considered under certain circumstances. For Greek students the admission criteria indicate that “Applicants who have successfully completed a Ptychion from a recognised Greek institution will be considered. As a general guideline, we will consider applicants with a grade in the region of 7.0 or above, although this will be decided upon by the admissions tutor at the time of application.”

As for the English language requirements: “A relevant English language qualification is also required — normally a minimum of 6.5 overall in IELTS (International English Language Testing System), however, this may vary from course to course. In some cases, it may be possible to consider the overall grade in the English language element of the Apolytirion of Geniko Lykeio or evidence of continued use of the English language since High School.”

Shipping Law (LLM)

The shipping industry's foundation is a network of cargo owners, ship owners and operators, banks and insurers. The industry represents over 90% of global trade, and inevitably disputes arise amongst the transactions which require legal aid. Furthermore, the potential exploitation of marine resources like mineral, fish and oil causes legal disputes between countries. This program provides students with theoretical and practical groundwork about maritime law and enables them to undertake in-depth research in order to acquire expertise in a certain field of commercial law. The LLM Shipping Law course offers a general appreciation of current issues in specific areas of the law. It stimulates a critical approach to evaluation of current and proposed regulation and cultivates independent and original thought.

The course comprises four taught modules totaling 120 credits which conclude Stage One of the program. Upon successful completion of the taught stage, you will progress to stage two, the 60 credit dissertation. The aim of this module is to enable students, by writing a dissertation, to develop the capacity to conduct independent and advanced research under limited supervision. "The University is committed to providing a wide range of module options where possible, but please be aware that whilst every effort is made to offer choice this may be limited in certain circumstances. This is due to the fact that some modules have limited numbers of places available, which are allocated on a first-come, first-served basis, while others have minimum student numbers required before they will run, to ensure that an appropriate quality of education can be delivered."

This course offers career prospects that are not limited within the legal profession. A law degree allows its holder to seek opportunities in finance, marketing, digital communications and human resources management. The university is cooperating with a wide range of partners, such as law firms, voluntary organizations and charities in order to extend the students' extracurricular opportunities.

The tuition fees are £7,950 (about 9,169€) for students from the United Kingdom and the European Union and £17,350 (about 20,010€) for students outside the EU. These fees may increase annually in line with inflation.

As for admission criteria, students should own at least a 2:1 class degree or equivalent in Law. Applicants with a 2.2 class degree or equivalent will be considered taking into account the application in its entirety. Furthermore, non-native English applicants must score an overall IELTS score of 6.5 with 6.5 in writing and 6.0 in all other components.



City, University of London – Cass Business School



Shipping, Trade and Finance (MSc)

The course aims to equip students with competitive skills and knowledge not only in the core area of shipping but also in the areas of commodity trade, ship finance, banking and investment. The students will develop their understanding of a wide range of economic issues that affect the shipping industry and all who work within it and acquire a comprehensive grasp of the interlocking disciplines of shipping, trade and finance.

The program comprises 3 terms within 12 months study period. The First Term starts at September 30 and concludes on December 13 with written exams from 6 January-17 January. The modules are:

- **Managerial Accounting:** Introduces the principles of accounting and finance in business and the main techniques in management accounting, planning and control. Covers the interpretation and use of annual reports and accounts, financial and ratio analysis, and their use for managerial decision-making, and budgetary control systems.
- **Principles of Finance:** Covers essential skills and knowledge in financial economics that will assist you in gaining an in-depth knowledge in the subject area as it is later taught in Corporate Finance. The aim of this module is to provide an introduction to the area of corporate finance. This will be achieved through the development of a common vocabulary and a set of tools that will assist students in gaining a basic understanding of what is corporate finance and it will lay the foundations for further study in this area.
- **Quantitative Methods:** Following the induction course, it covers descriptive and inferential statistics, as well as regression analysis techniques. Develops skills that are essential for other modules and the dissertation and is designed to ensure relevance to everyday business problems.
- **Research Methods and Professional Skills:** The module will utilize specific training in a financial modelling package in order to provide a strong foundation for the in-depth and specialist teaching and learning of terms two and three of your course. You will also learn how to gather information through database research, which you will be able to use to support your learning, substantiate your arguments and make assessments about the nature of the evidence you are using. Finally, you will bring these skills together by working in small groups for the preparation and presentation of a business plan proposal.
- **International Economics:** Explores the economic relationships between nations; international trade relations and benefits; the effects of barriers to trade and income distribution; trade policy; and international monetary relations. The significance of external influences on fiscal and monetary policy, the balance of payments and the theory and evidence of exchange rate determination all form part of this module, which also looks at the response of the exchange rate, and how these affect international trade.

- **Shipping Economics:** Focuses on the operational environment of the bulk-shipping sector. Subsequently discusses extensively the microeconomic structure of the four main markets (freight, second-hand, shipbuilding and demolition) in dry bulk and tanker shipping, together with the operational characteristics, international regulations and policies which affect these highly competitive, volatile, but nevertheless exciting industries. Continues with an introduction to liner and container shipping economics and concludes with a discussion of the principles of modern supply chain logistics, of which bulk shipping forms an integral part.

The Second Term starts at January 20 and concludes on April 3 with written exams from 20 April-1 May. The modules in this term are:

- **Advanced Quantitative Methods:** Builds on the knowledge acquired in Quantitative Methods in Part one and focuses on skills required for advanced analysis in areas such as risk management and forecasting.
- **Corporate Finance:** The aim of the course is to develop an understanding of modern corporate finance so that the corporate manager, the investment banker and the financial analyst will have the conceptual foundations for making informed corporate assessments of key financial decisions. Issues such as company valuation, dividend policy, raising equity and debt capital, capital structure and corporate governance are discussed in depth in class and are covered through case studies and presentations.
- **Financial Markets:** Covers the global economic and financial environment within which business corporations operate. Globalization and integration of markets for debt, equity and risk management have created new opportunities in the capital formation process, but pose great difficulties in navigating successfully. Where should capital be raised? How does one manage the risks from certain currencies and certain sovereign regions?
- **International Commodity Trade:** Discusses the theory and practice behind the development of modern patterns of trade, focusing on the world's major bulk commodities, such as grains, petroleum, and ferrous and non-ferrous ores. Considers in depth the distinctive microeconomic characteristics of key commodities, such as storability, perishability and seasonality; pricing mechanisms and methods of adjustment; the role derivatives in price determination; and the role of key producers and key markets in shaping market conditions.
- **Shipping Investment and Finance:** The skills developed in both Principles of Finance and Corporate Finance are applied to the shipping industry while introducing several new and important concepts to develop the ability and the analytical tools to make rational shipping investment and finance decisions. Making extensive use of case studies, areas covered include the fundamental principles of shipping investment and finance; vessel investment and disposal markets; investment feasibility studies; bank credit policy, bank credit analysis and proposals; raising equity and debt capital for shipping companies; tapping the public equity and debt markets; other sources of shipping finance such as leasing, export credit agencies and shipyard credit; and risk management in shipping.

In the Third Term the students are presented with three options, they can choose five specialist elective modules from a wide variety of courses (i.e. Chartering, Hedge Funds, Mergers & Acquisitions, Visual Basic in Finance, Shipping Law, Technical Analysis and Trading Systems, Innovation in Shipping, Commodity Derivatives and Trading, Financial Derivatives, Shipping Company Management, Shipping Risk Management, Shipping Strategy, Trade Finance) , or they can opt to write a 10,000-word Business Research Project and take one specialist elective module (Typical projects can involve any of the following: extracting data from electronic databases or by hand; statistical analysis of large or small populations; interviews; case studies of an industry or a sector or of a business / finance issue in a particular country setting) or they can opt to write a 5,000-word Applied Research Project and take three specialist elective modules.

The entry requirements for the course are a UK upper second class degree or above, or the equivalent from an overseas institution and for the applicants non-native to the English language, an IELTS level an average of 7.0 with a minimum of 6.5 in the writing section and no less than 6.0 in any other section.

The tuition fee is £25,500 (about 29,392€) with a £2,000 deposit paid within 1 month of receiving offer and non-refundable unless conditions of offer are not met. Fees in each subsequent year of study are subject to annual change.

The program provides a wide range of professional skills and offers employment opportunities in Shipping, Consulting Accounting/Auditing services and Investment Banking.

Energy, Trade and Finance (MSc)

This course provides students a solid foundation in energy economics, markets and trading, as well as detailed information on fossil fuels, electricity and renewables. The studies include energy transportation, especially seaborne and conclude with extensive study of finance and financial markets and essential skills in accounting and IT. On the Energy, Trade and Finance program students will develop their knowledge and understanding of generation from exhaustible and renewable sources, demand determinants, transportation, trading, and understand and critically evaluate current international issues in energy and commodities, finance and trade.

The program's duration is 12 months full-time which are divided in three study Terms and exams at the end of each term. The First Term starts at September 30 and concludes in December 13 with its' written exams on 6 January- 17 January. The modules in this term include:

- **Managerial Accounting**
- **Principles of Finance**
- **Quantitative Methods**
- **Research Methods and Professional Skills**
- **Energy Economics:** This module provides the fundamental knowledge of energy market economics, upon which the rest of the degree is built. It is one of the four cornerstone modules which define the MSc in Energy, Trade and Finance program.
- **Oil and Energy Transportation and Logistics:** The aim of the module is to equip you with tools necessary to think skillfully and maturely, but also independently, on matters relating to the transportation aspects of the energy industry. Industry trade journals and shipbroker reports contain vast information.

The Second Term starts at January 20 and concludes on April 3 with its' written exams on 20 April- 1 May. The second term's modules are:

- **Advanced Quantitative Methods**
- **Corporate Finance**
- **Financial Markets**
- **Oil and Energy Trading Economics and Finance:** This extended module provides the opportunity to focus on issues of particular importance to the specialist field of Energy, Trade & Finance.
- **Power and Renewable Markets:** The module focuses on the value chain of electricity, from its sourcing and generation to its supply, including the economics, pricing, policies and other pertinent issues. The module aims to place environmental and energy policies in context of the power sector, since governmental targets and the integration of renewable energy sources bring new challenges to these relatively new markets.

In the Third Term the students are presented with three options, they can choose five specialist elective modules from plethora courses (i.e. Chartering, Commodity Derivatives and Trading, Energy Law, Energy Project Investment and Finance, Financial Derivatives, Oil and Gas Business Management, Trade Finance, Financial Derivatives, Ethics, Society and the Finance Sector, Mergers & Acquisitions, Technical Analysis and Trading Systems, VBA with Application for Finance), or they can opt to write a 10,000-word Business Research Project and take one specialist elective module, or they can opt to write a 5,000-word Applied Research Project and take three specialist elective modules.

The tuition fee is £25,500 (about 29,392€) with a £2,000 deposit paid within 1 month of receiving offer and non-refundable unless conditions of offer are not met. Fees in each subsequent year of study are subject to annual change.

The entry requirements for the course are a UK upper second class degree or above, or the equivalent from an overseas institution and for the applicants non-native to the English language, an IELTS level an average of 7.0 with a minimum of 6.5 in the writing section and no less than 6.0 in any other section.

Maritime Operations and Management

This course is ideal for applicants with experience in the maritime field and for those that aspire to find a new career within the maritime, sea transport and offshore industries. The Maritime Operations and Management course is fixated towards providing students with the necessary knowledge in order to gain an understanding of the underlying principles upon which the industry is based. Additionally, successful completion of the course gives the maximum number of exemptions from the examinations of the Chartered Institute of Shipbrokers. As for career prospects, graduates from this course usually get employment opportunities either in the middle or higher management areas. Many former students on this course have now reached board level appointments in their various companies.

The duration is either 12 months full time or part time up to 48 months. The course consists of eight taught modules, six of which are compulsory and two elective to suit the students' needs and future career aspirations. The course is taught by 12 lecturers who come from academia and industry, and around six guest lecturers from various parts of the maritime industry. The course also offers visits to IMO and port facilities as well as other organizations.

The core modules include:

- Professional Studies
- Maritime Economics and Accounting
- Maritime Law
- Maritime Operations and Insurance
- Maritime Management
- Maritime Technology
- Environmental issues

As for the elective modules, if there is an insufficient number of students interested in a module, it may not be offered. The elective modules include:

- Marketing of Maritime Services
- Ports, Strategy and Development
- Security Studies
- Ship Design
- Risk Management
- Offshore Engineering and Operations
- Independent Study Mini Project

The entry requirements for those already working in the industry are: “a first degree, recognized professional qualification or the equivalent Certificate of Competence as Master or Chief Engineer: Class 1 Master Mariner or Class 1 Engineer and experience in one of these roles.”

For those coming from an undergraduate course: “a lower second class honours degree (or higher) in a relevant subject from a recognised institution.”

As for the English requirements, for students whose first language is not English a minimum score of 6.5 in the IELTS is required.

For students from the United Kingdom or the European Union the tuition fee is £12,000 (about 13,613€) for the full-time course and £6,000 (about 6,807€) per year for the part-time course.

For non-EU students the tuition fee is £16,800 (about 19,060€) for the full-time course and £8,400 (about 9,530€) per year for the part-time course.



Global Shipping Management, MSc

This course provides students with a combination of theoretical maritime topics and emerging industry trends in order to prepare them for the key challenges of the maritime industry. The course is delivered by expert from both industry and academia, and facilitates entrepreneurial methods such as software products and computer-based training from market leaders in the appropriate subject areas.

The Global Shipping Management program can be delivered in either full-time studies of 1 year or part-time studying of 2 years. The tuition fees for students from the UK or the EU are £9,250 (about 10,478€) and £14,500 (about 16,425€) for international students outside the EU. The core modules of the program are:

- **Accounting, Finance and Business Planning for the Shipping Industry:** This course provides the students with the necessary knowledge about the financial management of a ship-owning and a ship-management company, ranging from the basic nature of production of accounting reports to more complex issues of budgeting and financial aspect relating to the shipping industry, including ship finance options and hedging market risks. This course is being assessed by exams with a pass mark of 50%.
- **Maritime Economics and Global Business Management:** This course is intended to prepare the students for their general roles within a ship-management environment, by providing them with a broad knowledge on a variety of maritime economics and global business management and business subjects surrounding the global maritime industry. This course is being assessed by exams with a pass mark of 50%.
- **Research Methodology:** This module aims to equip students with perspectives in the philosophy, methodology, project planning and transferable skills such as presentation and communication skills, group working and report writing required to undertake effective scientific, engineering and management research. The assessment method used for this course is Continuous Assessment with a pass mark of 50%.
- **Strategy and Management:** This module aims to provide the students with an in-depth understanding of the strategic vision and the decision-making process and the link with operational management, and raise their understanding of the importance of strategic

planning, management and control. This course is being assessed by exams with a pass mark of 50%.

- **Marine Engineering Law and Insurance:** This course is intended to prepare the students in their general professional functions within the maritime industry environment by providing them with a specific knowledge on legal, regulatory and insurance topics. After completing this course successfully, the graduates will obtain knowledge that will undoubtedly prove essential in their professional activities onboard and ashore, and acquire the essential degree of confidence in dealing with situations that can potentially expose them to the world of claims and litigation.
- **Commercial Management of Ships:** The aims of this course are to provide the students with in-depth knowledge on the various activities surrounding the commercial exploitation of vessels. Subjects include the sale and purchase of ships, their profitable chartering and employment in all common forms and types including time spent in ports. The course further explores specific types of operations, such as liner and passenger trades and examines the impact of International sea transport policies together with IMO regulations that dictate future terms of trade and developments in the design of ships.
- **Technical Elements of Ships, Maritime Policies, Conventions and Regulations and Maritime Security:** The aim of this course is to provide the students with the necessary knowledge in three key areas of shipping operations, namely an understanding of the vessel's technical description and characteristics, the Legal framework of operation as established by Policies, Conventions & Regulations and the importance of protecting merchant vessels against maritime security risks, with emphasis on reinforcing ships against the threats of piracy.

The for the Global Shipping Management MSc program accepts students with an appropriate undergraduate degree in a business, law, science or technology discipline with at least a second-class award, and applicants with Merchant Marine or Royal Navy Officer qualifications (or overseas equivalent) with relevant sea-experience and/or equivalent shore-based work experience. As for the language requirements a minimum score of 6.0 in the IELTS test is obligatory.



Port Management, MSc

The program aims to provide students with a well-rounded view of the management of ports and port terminals and the varied logistics industry. The course covers container and bulk port operations and personnel issues in port labour management, and offers the chance to study the basics of maritime law and security management. The courses are delivered by the university's highly qualified academic team, combined with employer visits and lectures from guest speakers. The course has a full-time study mode of 12 months and consists of a number of core modules such as:

- **Global Transport Systems:** This module covers the range of transport options available in international shipping to provide an insight into operational and economic matters and to develop a framework for transport mode selection. It covers freight transport operations on an international scale, with particular reference to the role of intramodality.
- **Legal Principles:** This module introduces students to the fundamental legal principles of maritime law. It aims to introduce you to the legal systems of England and the EU and to provide a foundation of knowledge of the common law that underpins commerce.
- **Logistics Systems:** This module examines planning, management and operational issues within the supply chain, with particular focus to applications of the principles to the international environment. It aims to provide an insight into the principles of logistics management with particular reference to its application in the global business environment.
- **Port Administration:** This module provides you with an overview of the global port industry and the evolving role of ports. It presents the diverse roles of port authorities and examine the public interests and commercial factors that influence the administration of ports at national level, and governance of ports at the corporate level.
- **Port Business Strategy:** This module provides an appreciation of the functions of ports in international trade and transport logistics. Students will examine the commercial factors that have an impact on port strategy and will explore a range of management and business principles within the port context. The module aims to provide students with an insight into the strategic management of ports in dynamic, competitive environments.
- **Export Trade Law:** This module aims to assess the commercial law basis for international contracts of export sales and carriage. It will examine how cargo claim conflicts arise, and how such disputes are settled. The module aims to develop an understanding of law and practice in relation to export sales and the movement of goods.

- **International Trade:** This module provides a thorough introduction to key modern practices in international trade, with particular reference to the roles of significant international trade bodies and their impact. It aims to develop an understanding of the key influences affecting the international trade market, with particular reference to the impact they have on global logistics flows.
- **Marine Insurance:** This module deals methodically with the established principles of the Marine Insurance Act 1906, and examines case law developments. It examines the options for alternative policy terms available via the Institute Clauses, and examines proposals for the reform of the 1906 Act.
- **Maritime Finance and Economics:** This module examines issues relating to financial practice within the shipping industry, with appropriate reference to relevant macro- and micro-economic issues. It aims to develop a critical awareness of the economic environment in which ships are financed, traded and operated.
- **Maritime Security:** This module examines a range of matters in the field of maritime and port security through the analysis of a series of related case studies. It aims to evaluate a range of present-day security issues affecting the maritime and port areas, including an analysis of the effectiveness of mitigation policies and practices.

The tuition fees for students coming from the UK or the EU are £7,800 (about 8,835€) and for students outside the EU £14,450 (about 16,368€), and the entry requirements for the course are a minimum 2:2 honours degree in an engineering discipline or an equivalent professional qualification with relevant work experience. Additionally, there is an IELTS English language requirement: 6.0.

Marine and Offshore Engineering, MSc

This program provides the engineering skills and techniques required to work as a specialist in the marine and offshore engineering field. Graduates will be able to make a role to a company's capability and operation, and progress into senior management positions. With a combination of academic and professional expertise, as well as the university's well-established links with the industry and the international maritime research sector, the students are well prepared to meet the opportunities and challenges of this expanding sector.

The course combines substantial marine modules with mechanical engineering options in a 12 month full-time study period. Some of these modules include:

- **Maritime and Offshore Safety Analysis:** The module is designed to provide the underpinning knowledge and understanding to implement formal maritime safety assessment procedures. It enables you to understand and implement the requirements of formal safety design, assessment and review in marine, offshore and port areas.
- **Offshore Engineering:** This module is designed to provide advanced understanding of various offshore installation types and the engineering plants required to operate these installations.
- **Marine Design Engineering:** The module is designed to provide you with an in-depth grounding of the typical practices and procedures that you will encounter should you pursue a career in the Marine Engineering Design environment.
- **Advanced Materials Engineering:** This module provides an in-depth understanding of the structure and properties of advanced modern materials together with techniques available for improving properties of materials. It aims to develop a wide knowledge of advanced materials and to study the materials selection process involved in the design and manufacture of engineering products.
- **Finite Element Analysis:** This module extends your existing knowledge of the finite element method to an advanced level. It provides you with an in-depth understanding of the application of FEA to non-linear static and dynamic loading.
- **Computational Fluid Dynamics:** This module aims to appraise and distinguish the features of high performance CFD codes and introduces you to some of the intricacies associated with the modelling of fluid flow using CFD.
- **Alternative Energy Systems:** This module principally aims to provide a relatively detailed insight into the spectrum of alternative methods of power generation including associated issues such as global warming and connecting to the national grid system.
- **Modelling and Simulation:** This module introduces Matlab coding for scientific computation, and system simulation using Simulink. It enables those with a background in using a traditional high-level programming language, but no experience using National Instruments (NI) LabVIEW, to create virtual Instruments (VI's) and interface them with compatible hardware for data acquisition (DAQ) and control applications.

The tuition fees for students coming from the UK or the EU are £7,800 (about 8,835€) and for students outside the EU £14,450 (about 16,368€), and the entry requirements for the course are a minimum 2:2 honours degree in an engineering discipline or equivalent professional qualification such as Maritime Coastguard Agency Class 1 (Marine Engineer) certificate of competence.

Additionally, there is an IELTS English language requirement: 6.0.

International Transport, Trade and Logistics, MSc

This dynamic course will provide students with the tools to establish a comprehensive understanding of knowledge relating to International Transport, Trade and Logistics. International trade is vital aspect of the global economy and it is taking on even greater importance with the development of growing economies within the manufacturing sector. Global trends in the field are graduating from the emphasis on the transportation element, moving towards a more cohesive system of management and communications. Skills in these systems are in demand in the industry, and this course ensures its graduates are ready to face industry related issues. The course is delivered in a 12-month duration with tuition fees for students coming from the UK or the EU are £7,800 (about 8,835€) and for students outside the EU £14,450 (about 16,368€).

The core modules of the International Transport, Trade and Logistics, MSc include:

- **Export Trade Law:** This module aims to appraise the commercial law basis for international contracts of export sales and carriage. It will examine how cargo claim conflicts arise, and how such disputes are settled. The module aims to develop an understanding of law and practice in relation to export sales and the movement of goods with particular reference to the carriage of goods by sea.
- **Global Transport Systems:** This module covers the range of transport options available in international shipping to provide an insight into operational and economic matters and to develop an outline for transport mode selection. It covers freight transport operations on an international scale, with particular reference to the role of intramodality.
- **International Trade:** This module provides a thorough introduction to key contemporary concepts and practices in international trade, with particular reference to the roles of significant international trade bodies and their impact. It aims to develop an understanding of the key influences affecting the international trade market, with particular reference to the impact they have on global logistics flows.
- **Logistics Systems:** This module examines planning, management and operational issues within the supply chain, with particular reference to applications of the principles to the international environment. It aims to provide an insight into the principles of logistics management with particular reference to its application in the global business environment.
- **Operations Research:** This module introduces a set of fundamental techniques and tools to improve decision-making in real world management issues. It will teach you how to model an operational problem in your business or organization, how to select and apply a quantitative method to solve it, and how to interpret the results to make a better management decision.
- **Supply Chain Modelling:** Through the use of appropriate modelling techniques, this module evaluates supply chain operations in a quantitative way to allow for optimization of performance. It aims to equip you to use a variety of quantitative methods to analyze and solve problems in logistics.
- **Information Management and Communication Systems:** This module introduces you to applications of position-finding technology and IT systems for port and transport industry. It aims to analyze the operation and impact of a wide-range of information technology applications within the maritime, ports and trade environment.

The entry requirements for this course require a minimum score of 6.0 in the IELTS test for non-native English speakers and a minimum 2:2 honours degree in a relevant subject or an equivalent professional qualification such as a UK Class 1 Master Mariner or Chief Engineer certificate of competence.

Master of Laws, LLM

The aim of this program is to create a constructive learning environment for students in which they can practice advanced research and gain academic and intellectual progression, together with the acquisition of specific knowledge and skills. This course is suitable for students wishing to broaden their legal knowledge, since its purpose is to analyze key themes in law and criminal justice and global crime and will challenge your thinking and stimulate your academic aspirations in these fields.

The Master of Laws LLM is delivered with a combination of core and optional modules in a 12-month full-time schedule or 2-year part-time schedule. The core modules are:

- **Advanced Legal Research Methods:** This module introduces research methodologies available for conducting research in law and criminal justice. It aims to facilitate development of Masters-level technical legal and criminal justice research, encourage a Masters-level degree of independence and responsibility, introduce key research methodologies for researching law and criminal justice and develop the technical research requirements of a Masters dissertation.
- **Dissertation:** This module will enable you to undertake a detailed study of a clearly defined legal or criminal justice topic, issue or problem. It aims to increase knowledge of a selected subject area and develop a greater critical awareness and present findings in an appropriate form.

The optional modules include:

- **Drugs, Alcohol and Criminal Justice:** This module aims to develop your understanding of drug and alcohol use within contemporary society. It deconstructs the drug and alcohol status quo so you can acknowledge the complexities and contradictions that exist within this sphere.
- **Crime, Power and Victimization:** This module is designed to examine the social construction of crime. It aims to provide a balance between theoretical perspectives and empirical, practical knowledge about the power imbalances in society, and equip students with the skills required to demonstrate a critical understanding of crimes involving the abuse of social and individual power.
- **Delivering Rehabilitation:** This module critically evaluates the role of the prison and probation services in relation to the delivery of state punishment and rehabilitation. It aims to reflect on the principles that underpin the delivery of current penal policy through the creation of the National Offender Management Service (NOMS).
- **The Police, Policing and The Governance of Security:** This module seeks to explore the relationship between policing services and members of the diverse public. It will help develop an appreciation of the historical and conceptual development of modern policing forms, evaluate contemporary policing structures, and explore future challenges for service provision.
- **The United Nations, International Security and Global Justice:** The module aims to introduce you to the work of the United Nations in the maintenance and restoration of international peace and security and develop your understanding of the legal framework which governs the work of the UN in this area.
- **EU Foreign Security and Justice Policy:** This module enables you to examine and critically analyze contemporary issues arising from the EU Foreign, Security and Justice Policy. You will also be able to consider contemporary global problems through EU law and policy.
- **International Trade and Finance Law:** This module allows you to critically analyze contemporary legal issues regarding international trade.
- **International Financial Crime:** The module allows you to undertake an analysis of the law as it relates to a range of contemporary issues in financial crime. It aims to provide

knowledge and understanding of the impact of a range of financial crimes.

- **International Maritime Law:** This module aims to introduce the basics of International Maritime Law, develop a critical understanding of commercial maritime issues and adequacy of the published material in maritime law, help students consider the adequacy of the current legal structure of the modern maritime contract and facilitate critical assessment of contemporary issues surrounding the commercial vessel in law.

The tuition fees for students coming from the UK or the EU are £6,600 (about 7,476€) and for students outside the EU £13,950 (about 15,802€), and the entry requirements for the course are a minimum 2:2 in a subject such as Law, Criminal Justice, Politics, Finance, Banking or Accounting or an equivalent professional qualification. As for the English language requirements, for non-native English speakers a minimum score of 6.0 in the IELTS test is a must.

Logistics and Supply Chain Management, MSc

The program focuses on markets, customers, finance, people, operations, communications and information technology, and business policy and strategy. It helps students learn about manufacturing operations management, the fundamentals of production planning, inventory control and process modelling and discover how goods are moved around the world within the logistics system. Students will analyze the components of a logistics system and appraise current developments and they will apply operations research techniques to solving business problems in the sector. This course is delivered on a 12-month full-time study mode with a wide range of core modules. Each module is delivered over a period of five to six weeks and appeals to an international audience. Some of the core modules include:

- **Manufacturing Management:** This module aims to provide an introduction to manufacturing operations management. It focuses on the manufacturing plant and services covering the fundamentals of production planning, inventory control, and process modelling and control.
- **Global Transport Systems:** This module covers the range of transport options available in international shipping to provide an insight into operational and economic matters and to develop a framework for transport mode selection.
- **Data Systems for Maritime and Logistics:** This module examines a range of specific issues which you may encounter in a complex supply chain environment, including those which relate to the connectivity between logistics processes and manufacturing. It aims to analyze advanced information technologies and systems used by organizations within the logistics and supply chain sector to manage information, business processes and decision making.
- **International Trade:** This module provides a thorough introduction to key contemporary concepts and practices in international trade, with particular reference to the roles of significant international trade bodies and their impact. It aims to develop an understanding of the key influences affecting the international trade market, with particular reference to the impact they have on global logistics flows.
- **Supply Chain Modelling:** Through the use of appropriate modelling techniques, this module evaluates supply chain operations in a quantitative way to allow for optimization of performance. It aims to equip you to use a variety of quantitative methods to analyze and solve problems in logistics.
- **Safety and Reliability:** This module aims to cover the application of modern risk management techniques for the identification, evaluation and control of the risk to enable improvements in the safety and reliability of engineering systems. It allows you to investigate and apply risk analysis and safe engineering techniques within an industrial setting, including the associated human factors.
- **Information Management and Communication Systems:** This module introduces you to applications of position-finding technology and IT systems for port and transport industry. It aims to analyze the operation and impact of a wide-range of information technology applications within the maritime, ports and trade environment.

The tuition fees for students coming from the UK or the EU are £7,800 (about 8,835€) and for students outside the EU £14,450 (about 16,368€), and the entry requirements for the course are a minimum 2:2 honours degree in an engineering discipline or equivalent qualification such as BEng or Meng. As for the English language requirements, for non-native English speakers a minimum score of 6.0 in the IELTS test is a must.
