I, Captain Kate Zen, Master of the vessel Karma,	. lodge this Letter of Protest	the delay
experienced by my vessel at the Port of Piraeus on 25/04	l/25, specifically	the extended time taken
for the release of results from cargo sample analysis.		

The sampling was carried out on 23/04/25, and we were advised that the results would be made available within 24 hours. However, as of the date and time of this letter, no definitive results have been communicated. This delay is causing significant disruption to our schedule, potential financial losses, and operational complications, including but not limited to:

- Extended or anchorage occupancy,
- Loss of charterer's time,
- Increased fuel and port charges,
- Potential of laytime and demurrage implications.

While I understand the importance of ensuring safety and through cargo sampling and analysis, the
delay in processing and communicating the results is unacceptable and adversely affecting the interests of all
stakeholders involved. I place you on and strongly protest you and hold you
responsible and for any whatsoever from cargo interests or third parties for delaying cargo
operations. I the rights of my Owners and Charterers to refer to this matter, at some later date, and
take any actions, as they may necessary, as a direct result of this incident.
